
In view of the Medical Council Elections, it is the responsibility of TSMC members to keep facts in front of Allopathic doctors and try to clear some frequently asked questions.




T.S.M.C performance

For a fair TSMC Election Follow the guidelines given by election commission (see TSMC Website)

Receive Ballot paper by Registered post, Vote Genuine candidate and personally post by registered post back to Returning Officer.



- Q1 Is TSMC An Autonomous Body or Dependent Body on Govt ?
- Ans. It is quasi judiciary autonomous body enacted by State Legislature
- Q2 As per the TSMC Act, Does the Elected Member has any Power to take ACTION against Quackery among Our own Allopathy Doctors?
- Ans. Medical Council consisting of Nominated members (6)+Ex-officio members(4)+Elected members(2 elected by KNRHS+13 elected by all allopathic doctors). Ethics committee of council (not only elected members) can take action on complaint or suo motto.
- Q3 Does the TSMC has any power to constitute any committee on Quackery independently?
- Ans. Yes. If the Council feels if it is necessary to constitute it can constitute any committee as per Chapter IV, Sec 12.
- Q4 Can an individual or Group of Elected Members Act/work Beyond TSMC Act ?

Ans. No.



Q5 | Does the TSMC has any Power to take Action against Quackery Independently ?

Ans. Yes if he/she is allopathic Doctor - According to Chapter VII Sec 20 (ii) is read as "No person other than a registered practitioner shall, with effect from such date as may be specified by the Government by notification in this behalf, practice the modern medicine or hold himself out, whether directly or by implication as practicing or as being prepared to so practice".

Sec 21 is read as "whoever falsely represents himself to be a registered practitioner shall, whether any person is actually deceived by such representation, be punishable with fine which may extend to five hundred rupees".

Sec 22 is read as "Whoever contravenes the provision of clause (ii) of Section 20 shall be punishable on first conviction with imprisonment which may extend to three months or with fine which may extend to five hundred rupees or with both, and on any subsequent conviction with imprisonment which may extend to six months or with fine which may extend to one thousand rupees or with both".

Q6 Does TSMC has POWERs to Take ACTION against on NON-TSMC Members ?

- Ans. Yes. If he/she is an allopathic doctor. If he/she is non allopathic member found guilty, you can file a case in the court/you can request/complaint to DMHOs, Police officer/AYUSH board to take action.
- Q7 Can TSMC Members Bring Reforms/Changes by Bypassing the TSMC Act?
- Ans. No. All the members should follow the TSMC Act. If TSMC Members wishes to bring any reforms/Changes, the same should be amended in the Act by way of passing in the State Legislative Assembly.
- Q8 Does The Govt has any Power to take action against TSMC Members, if any TSMC member Abuse its Powers **?**
- Ans. Yes. Govt can ask Report from Chairman, can form committee and can suspend member or abolish council with the approval of cabinet.



- Q9 Is it mandatory for TSMC To take Permission from State Govt & Legislative Assembly to Frame Rules / Committee & Action on Quackery ?
- Ans. Yes. To amend any rules/regulations to the TSMC Act, it should be passed in the State Legislative Assembly. As per the NMC guidelines, action on quackery is vested with the powers of the Council
- Q10 Why Did it Took 17Yrs to Conduct TSMC Elections ?
- Ans. TSMC formed by adopting APMP Regn Act 1968, G.O.Ms No 68 HM&FW (C1) Dept, Dt 03-08-2015,

TSMC started functioning by allotting TSMC registration numbers from 01-02-2016. Govt formed TSMC Intrem Council by releasing G.O no 15 FW (C1) Dept Dt: 06-01-2016.

Nominated Council formed by G.O no 229, dt 23-04-2022.

Q 11	What did we loose, for Not Conducting TSMC Elections for 17yrs ?	
Ans.	We TSMC members don't understand who lost what?. TSMC has been functioning effectively. 17 years is miss leading to allopathic doctors.	
Q12	Are the Contestants Misleading Young Doctors on Quackery ?	
Ans.	Yes. We at TSMC formed central Anti-quackery committee which act through anti- quackery committees formed in all districts. Acting on complaints one by one. Taking action on allopathic quacks, complaining and urging DMHOs, Police officers and concerned officials to take action when non allopathic quacks are involved.	
Q13	Apart from Charging Rs 500/- Penalty, Can TSMC take any Further Legal Action on Quackery as per TSMC Act ?	
Ans.	As per the TSMC Act, action on non allopathic quacks is limited. As per the NMC guidelines there is a scope to take action on non allopathic quacks but require DMHOs, Police officers & state Govt cooperation. State Govt is also serious about removing quacks by establishing medical colleges in each district so that the quackery will self dies.
